## **Natural Resources Agency Announces Awards for the Environmental Enhancement and Mitigation Grant Program**

SACRAMENTO, Calif. – The California Natural Resources Agency today announced \$16.2 million in funding for 35 Environmental Enhancement and Mitigation Program (EEM) projects statewide. EEM provides grants to local, state and federal governmental agencies and nonprofit organizations for projects to mitigate environmental impacts caused by new or modified state transportation facilities.

“This is an impressive list of projects that will go a long way in reducing the impacts of new and upgraded transportation infrastructure,” said California Natural Resources Agency Secretary John Laird. “These funds will result in projects that protect and restore key watersheds for habitat and water supply, sequester carbon and reduce environmental pollution.”

For fiscal year 2013-14, the agency evaluated 67 applications and recommended funding for 35 projects identified below. Specifically, the agency recommends funding 18 projects in the northern part of the state for a total of \$7,893,180 and 17 projects in the southern portion of the state totaling \$8,345,950.
